A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA COMMITTING LOCAL FUNDS AS LEVERAGE FOR THE 1990-91 COMMUNITY DEVELOPMENT BLOCK GRANT APPLICATION.

WHEREAS, that application indicates that \$50,000 will be committed by the City of San Luis as leveraged funds, in the form of (e.g. city crew, materials, administrative staff) and

WHEREAS, the Commerce 1990-91 Program Summary requires that all local leveraged funds or resources be committed in the form of a resolution by the governing body, and that such a commitment contain an opinion by the applicant's legal counsel that the leverage funds represented a binding commitment, legally enforceable under State laws.


