A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, COUNTY OF YUMA RENDERING SUPPORT TO THE YUMA COUNTY AIRPORT AUTHORITY APPLICATION TO APPLY TO THE FOREIGN TRADE ZONES BOARD OF THE UNITED STATES DEPARTMENT OF COMMERCE TO DESIGNATE A PORTION OF YUMA INTERNATIONAL AIRPORT AS A FOREIGN TRADE ZONE.

WHEREAS, the City of San Luis City Council, is concerned with the economic growth and increase the job base in the greater Yuma metropolitan area, and

WHEREAS, the Yuma County Airport Authority, Inc. is in the process of applying to the Foreign Trade Zones Board of the United States Department of Commerce to designate a portion of Yuma International Airport as a Foreign Trade Zone, and

WHEREAS, the City of San Luis City Council believes that a Foreign Trade Zone located at the Yuma International Airport will provide a major stimulus to the growth of industry in the greater Yuma area, and enhance the region's efforts to attract new industry, and will further act to enhance the status of the Airport as a center for cargo operations, and

WHEREAS, in view of the North American Free Trade agreement, international trade with Mexico is expected to dramatically increase, and

WHEREAS, the location of the Yuma International Airport, and the proposed Foreign Trade Zone, make it well suited to capitalize on that growth,

NOW THEREFORE, be it resolved that the City of San Luis City Council hereby formally states its strong support for the application of the Yuma County Airport Authority, and directs its City Manager to cause a copy of this resolution to be delivered to the Authority, and


