WHEREAS, the City of San Luis needs the State Land Department's approval to annex State lands,



Section Two: That this resolution is not binding upon the Mayor and Council of the City of San Luis, should they decide in the future to not annex the property and this is simply a request that the State Land Department allow the City of San Luis to annex the above described State lands should the City of San Luis decide that it is in the best interest of the City of San Luis to annex the State lands.






