RESOLUTION NO. 551

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY/RECALL ELECTION HELD ON MARCH 9, 2004, IN THE CITY OF SAN LUIS, ARIZONA.

WHEREAS, the City of San Luis, Yuma County, Arizona did hold a primary election on the 9th day of March, 2004, for the nomination/election of three (3) Council Members, and a recall for one Council Member seat;

WHEREAS, the recall election returns have been presented to and have been canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of San Luis, Yuma County, Arizona, as follows:

SECTION 1. That the total number of ballots cast at said primary/recall election as shown by the poll lists was 2021.

SECTION 2. That the number of ballots to be verified was 61.

SECTION 3. That the total number of spoiled ballots was 11.

SECTION 4. That the votes cast for the candidates for Council Member were as follows:

Luna, Luis


SECTION 6. That the votes cast for the candidates for the council member position held by Carlos Bernal were as follows:

Bernal, Carlos	1,117



SECTION 8. This Resolution shall be in full force and effect immediately upon its adoption.


