Resolution No. 561

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE RECALL ELECTION HELD ON MAY 18, 2004, IN THE CITY OF SAN LUIS, ARIZONA.

WHEREAS, the City of San Luis, Yuma County, Arizona did hold a recall election on the 18th day of May, 2004, for two council member seats.

WHEREAS, the recall election returns have been presented to and have been canvassed by the City Council;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of San Luis, Yuma County, Arizona, as follows:

SECTION 1. That the total number of ballots cast at said recall election as shown by the poll lists was 2,035.

SECTION 2. That the number of ballots to be verified was 305.

SECTION 3. That the total number of spoiled ballots was 9.

SECTION 4. That the total number of rejected ballots was 21.

SECTION 5. That the votes cast for the candidates for the Council Member position held by Gloria Torres were as follows:


SECTION 7. That the votes cast for the candidates for the position held by Juan Carlos Escamilla were as follows:

SECTION 9. This Resolution shall be in full force and effect immediately upon its adoption.


