RESOLUTION NO. 600

A RESOLUTION OF THE CITY OF SAN LUIS, ARIZONA
ADOPTING A FEE SCHEDULE FOR OCCUPATIONAL LICENSES;
REPEALING ANY CONFLICTING PROVISIONS; AND PROVIDING
FOR SEVERABILITY

BE IT RESOLVED by the Mayor and Council of the City of San Luis, Arizona, as follows:

Section 1: The following fee schedule is hereby adopted as the Occupational License Fee Schedule of the City of San Luis:

Occupational License Tax Schedule.

A. Unless otherwise specified, all resident business and nonresident business merchants, retail, non-retail, or wholesale, shall pay an occupational license tax in the amount of \$100.00 per year.

B. The occupational license tax for the following specified businesses shall be:

Circus or ring shows, menageries or other like shows
\$60 per day

Circus parades
\$60 per day

Dance halls, public
\$500.00

Exhibition promoter

\$250.00

Plus, for each participating itinerant merchant, per day
\$25.00

Itinerant business per person selling
\$100.00

(1) Halloween: Sales allowed between October 15th and November 5th inclusive. Products authorized: Pumpkins and related Halloween accessories. The occupation license tax is \$25 per the stated period,

(2) Christmas: Sales allowed between November 25th and December 25th, inclusive. Products authorized: Christmas trees. The occupation license tax is \$25 per the stated period.

Amendment to existing business license
\$15 per amendment

Section 2: In the event of a conflict between the provisions of this resolution and any other ordinance, resolution, regulation, or policy of the City of San Luis, the conflicting provisions are hereby repealed, superseded, and replaced, and the provisions of this resolution shall govern.

Section 3: If any section, subsection, sentence, clause, phrase, or portion of this Resolution is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Resolution.


