## RESOLUTION NO. 604

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, COUNTY OF YUMA COMMITTING UP TO \$40,000.00 OF HIGHWAY USER REVENUE FUNDS ("HURF") AND/OR CITY FUNDS TO INSURE THE COMPLETION OF PHASE I OF A MULTIPHASE PUBLIC WORKS PROJECT THAT USES FY 2005 COMMUNITY DEVELOPMENT BLOCK GRANT ("CDBG") MONEY IN ONE OR MORE OF ITS COMPONENTS.**

**WHEREAS, the City of San Luis participates in the Community Development Block Grant Program (CDBG) and desires to apply for, receive, and expend FY 2005 CDBG funds for the benefit of eligible individuals and households residing within its jurisdiction;**  
**and**

**WHEREAS, the State of Arizona Community Development Block Grant Program requires that, for certain types of CDBG-funded construction projects, local officials pass a Resolution certifying the commitment of additional local financial resources necessary to complete that project or to complete a specific portion thereof;**  
**and**


**WHEREAS, the City of San Luis intends to use some of its FY 2005 CDBG funds in a phased public works project;**


