A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 16, 2006, IN THE CITY OF SAN LUIS, ARIZONA.

WHEREAS, the City of San Luis, Yuma County, Arizona did hold a General Election on the 16th day of May, 2006, for the election of one (1) Mayoral seat and three (3) Council Member seats;

WHEREAS, the General Election returns have been presented to and have been canvassed by the City Council;


