A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, COUNTY OF YUMA AUTHORIZING THE SUBMISSION OF APPLICATIONS FOR FY 2007/2008 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS, CERTIFYING THAT SAID APPLICATIONS MEET THE COMMUNITY'S PREVIOUSLY IDENTIFIED HOUSING AND COMMUNITY DEVELOPMENT NEEDS AND THE REQUIREMENTS OF THE STATE CDBG PROGRAM, AND AUTHORIZING ALL ACTIONS NECESSARY TO IMPLEMENT AND COMPLETE THE ACTIVITIES OUTLINED IN SAID APPLICATIONS.

WHEREAS, the City of San Luis is desirous of undertaking community development activities; and

WHEREAS, the State of Arizona Development Block Grant Program is administering the Community Development Block Grant Program; and

WHEREAS, the State CDBG Program requires that CDBG funds requested address one of three Congressionally mandated National Objectives; and

WHEREAS, the activities within these applications address the community's identified housing and community development needs, including the needs of low and moderate income persons; and

WHEREAS, an Applicant of State CDBG funds is required to comply with the program guidelines and Federal Statutes and regulations.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the City of San Luis, Arizona, County of Yuma authorize application to be made to the State of Arizona, Department of Housing for FY 2007/2008 funds, and authorize the Mayor to sign application and contract or grant documents for (1) \$573,343.00 of State of Arizona Regional Account ("RA") funds for City of San Luis Public works project, of which \$543,955.00 shall be allocated for Curbs, Sidewalks, Gutters, and Alleyways within the city limits, and of which \$29,388.00 shall be allocated for the administration of the City of San Luis CDBG projects; and (2) \$300,000.00 for the purchase and outfitting of a fire truck, the funding application for which shall be submitted to the State of Arizona for consideration as a State Special Project ("SSP"), and authorize the Mayor to take all actions necessary to implement and complete the activities submitted in said application (s); and

THAT this application for State CDBG funds meets the requirements of low- and moderate-income benefit for activities justified as benefiting low- and moderate-income persons, or aiding in the prevention or elimination of slum and light, or addressing an urgent need which poses a threat to health; and


THAT the City of San Luis will comply with all State CDBG Program Guidelines, Federal Statutes and regulations applicable to the State CDBG Program and the certifications contained in these applications.


