RESOLUTION NO. 806

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA RELINQUISHING THE SOUTH 90 FEET OF LOT 13, SECTION 12, TOWNSHIP 11 SOUTH, RANGE 25 WEST, GILA AND SALT RIVER MERIDIAN, YUMA COUNTY, ARIZONA (FRIENDSHIP PARK) TO THE UNITED STATES OF AMERICA

Whereas the City of San Luis, Arizona received a transfer of Patent Number 02-74-0026 from the Bureau of Land Management of the United States of America for the parcel known as Lot 13, South, Section 12, Township 11 South, Range 25 West, Gila and Salt River Meridian, Yuma County, Arizona (hereinafter referred to as the "Parcel"), commonly known as Friendship Park, for park and recreation purposes on or about December 16, 1983;


Whereas the approval of said patent was subject to the reversionary provisions of the Recreation and Public Purposes Act of June 14, 1926, as amended by the Act of June 4, 1954 (63 Stat. 173; 43 U.S.C. 869), as amended;

Whereas, the Department of Homeland Security needed the south 90 feet of the Parcel for the construction of security improvements at the United States border and has constructed those improvements; and

Whereas the Bureau of Land Management of the United States of America has requested the City of San Luis to begin the process of relinquishment of the aforementioned south 90 of the Parcel;


NOW THEREFORE BE IT RESOLVED by the Mayor and City Council of the City of San Luis, Arizona that the City of San Luis, Arizona hereby agrees to relinquish its patent to the South 90 feet of Lot 13, South, Section 12, Township 11 South, Range 25 West, Gila and Salt River Meridian, Yuma County, Arizona to the United States of America pursuant to the terms of the patent for said Parcel as given to the City of San Luis as foretasted, and hereby designates the City Manager to represent the City in said matter, and he is hereby authorized and directed to sign such documents as may be necessary, including but not limited to a Quit Claim Deed of Reconveyance, to effectuate said relinquishment.

Passed and adopted by the San Luis City Council this 14th day of January, 2008, in the City of San Luis, Arizona.






