## RESOLUTION NO. 872

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON MARCH 9, 2010, IN THE CITY OF SAN LUIS, ARIZONA.

**WHEREAS**, the City of San Luis, Yuma County, Arizona did hold a Primary Election on the 9<sup>th</sup> day of March, 2010, for the nomination/election of one (1) Mayoral seat and three (3) Council Member seats;

**WHEREAS**, the Primary Election returns have been presented to and have been canvassed by the City Council;

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and Council of the City of San Luis, Yuma County, Arizona, as follows:

**Section 1:** That the total number of ballots cast at said primary election, as shown by the poll lists, was 2,983.

**Section 2:** That the total number of provisional ballots was 126.

**Section 3:** That the total number of provisional ballots to be verified was 76.

**Section 4:** That the total number of spoiled ballots at the polls was 9.

**Section 5:** That the votes cast for the candidates for Mayor were as follows:
