## RESOLUTION NO. 944

### **A RESOLUTION OF THE SAN LUIS CITY COUNCIL ADOPTING THE UPDATED SAN LUIS GENERAL PLAN KNOWN AS THE "CITY OF SAN LUIS 2020 GENERAL PLAN"; AND RATIFYING SUBMISSION OF THE PLAN FOR A PUBLIC VOTE.**

**WHEREAS**, the "City of San Luis 2020 General Plan" has been prepared and is in accordance with adopted state legislation for cities outlined under Arizona Revised Statutes § 9-461.05, and;

**WHEREAS**, the "City of San Luis 2020 General Plan" has been prepared in compliance with Arizona Revised Statutes § 9-461.06, and;

**WHEREAS**, the City of San Luis heretofore approved the preparation of a 2020 General Plan for the City, making provisions for land use, transportation/circulation, economic development, housing, open space and recreation, public facilities, environmental planning/water resources and community design, and;

**WHEREAS**, the proposed plan was presented to the City of San Luis Planning & Zoning Commission and they held two separate Public Hearings pursuant to state law at the Cesar Chavez Cultural Center on June 7, 2011 and at the City of San Luis City Council Chambers on June 14, 2011; and

**WHEREAS**, after these mandated Public Hearings, the Planning & Zoning Commission recommended Approval at their June 14, 2011 meeting of the proposed plan to the City Council; and

**WHEREAS**, the City of San Luis City Council has scheduled the "City of San Luis 2020 General Plan" for a public vote on November 8, 2011; and

**WHEREAS**, the City Council of the City of San Luis conducted a Public Hearing on July 13, 2011;

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the City of San Luis as follows:

Section 1. That the "City of San Luis 2020 General Plan" three copies of which are on file with the City Clerk is hereby declared to be a public record.

Section 2. That the "City of San Luis 2020 General Plan" is hereby adopted and approved.

Section 3. That the action of Resolution No. 943 of the City of San Luis in submitting the "City of San Luis 2020 General Plan" to the residents of the City of San Luis for a public vote on November 8, 2011 is hereby ratified and approved.


