## RESOLUTION NO. 970

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON MARCH 13, 2012, IN THE CITY OF SAN LUIS, ARIZONA.

**WHEREAS**, the City of San Luis, Yuma County, Arizona did hold a Primary Election on the 13<sup>th</sup> day of March, 2012, for the nomination/election of four (4) Council Member seats;

**WHEREAS**, the Primary Election returns have been presented to and have been canvassed by the City Council;

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and Council of the City of San Luis, Yuma County, Arizona, as follows:

**Section 1:** That the total number of ballots cast at said primary election, as shown by the poll lists, was 2,385.

**Section 2:** That the total number of provisional ballots was 138.

**Section 3:** That the total number of provisional ballots to be verified was 128.

**Section 4:** That the total number of spoiled ballots was 10.

**Section 5:** That the votes cast for the candidates for Council Members-4 year term were as follows:

**Section 10:** This resolution shall be in full force and effect immediately upon its adoption.


