A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA APPROVING INTERGOVERNMENTAL AGREEMENT FOR FIELD TRAINING BETWEEN THE CITY OF SAN LUIS, ARIZONA AND SUPERIOR COURT IN YUMA COUNTY.

Whereas, the City of San Luis desires to enter into an intergovernmental agreement with Superior Court in Yuma County for the provision of court staff training; and

Whereas, the parties to the Intergovernmental Agreement desire to enter said agreement; and

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of San Luis, State of Arizona, as follows:

Section 1: That the Intergovernmental Agreement, as attached hereto as Exhibit "A", is hereby approved.

Section 2: That the appropriate City officials are hereby authorized and directed to enter into said agreement on behalf of the City and take any all actions as may be necessary to effectuate said agreement.



Gentlemen:

Enclosed is a revised Letter Amendment to the Intergovernmental Agreement ("IGA") between the City of Somerton and Superior Court in Yuma County. I apologize for the scrivener's error in the Letter Amendment dated June 8, 2012.

The revised Letter Amendment extends the term of the IGA between the City of San Luis and Superior Court in Yuma County for one (1) year beginning as of July 1, 2012 and ending June 30, 2013.

Also enclosed is a copy of the original IGA between the City of San Luis and Superior Court, dated August 1, 2008. My recollection is that the IGA was never signed, but San Luis honored the terms of the IGA by sending the court a check each year for its annual participation in Yuma County Field Trainer program. Please see copies of Treasurer's Receipts from FY08-09 through FY11/12. Each receipt reflects the payment by San Luis of \$1,000 that is used to reimburse Superior Court for a portion of the personnel expenses of the Field Trainer. The receipt for FY09/10 reflects payment of \$2,200 which was apparently a combined total contribution from the City of Somerton and City of San Luis; all other receipts are for San Luis.

We appreciate the continued support of the City of San Luis with the Field Trainer program.

ADDENDUM TO INTERGOVERNMENTAL AGREEMENT  
BETWEEN  
YUMA COUNTY AND CITY OF SAN LUIS  
FOR  
Weekend and Holiday Municipal Court Coverage

Pursuant to paragraph 2 of the original intergovernmental agreement dated April 4, 2011 and recorded with the Yuma County Recorder for the provision of weekend and holiday municipal court coverage, it is hereby agreed upon by the parties to exercise the option to extend said agreement for an additional one year period beginning July 1, 2011 and terminating on June 30, 2012. The City shall pay the County \$1,275.66 for the period covered under this extension. All of the terms and conditions contained in the original intergovernmental agreement remain in full force and effect during the extended term.






