A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA APPROVING ADDENDUM TO INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF SAN LUIS, ARIZONA AND CITY OF SOMERTON FOR FIRE PERSONNEL SERVICES DATED JUNE 22, 2012

Whereas, the City of San Luis and the City of Somerton entered into an intergovernmental agreement for the provision of fire personnel services dated June 22, 2012;

Whereas, section five of said intergovernmental agreement provides that the City of Somerton may ask for an adjustment in the charges imposed by said section; and


Whereas the parties have agreed to an adjustment in accordance with the aforesaid provision;

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of San Luis, State of Arizona, as follows:

Section 1: That the Addendum to Intergovernmental Agreement, as attached hereto as Exhibit "A", is hereby ratified and approved.

Section 2: That the appropriate City officials are hereby authorized and directed to enter into said addendum on behalf of the City and take any all actions as may be necessary to effectuate said agreement.



ADDENDUM TO FIREFIGHTER AGREEMENT

Whereas, the City of San Luis and the City of Somerton in 2011 entered into an agreement for provision of fire personnel services, said agreement becoming operational in December of 2011;

Whereas, Section 5 of said agreement provides, in part, that the City of Somerton may request a modification of charges for housing Somerton firefighters in the event that Somerton faces financial difficulties in maintaining operations in San Luis; and

Whereas, the City of Somerton has requested such modification for charges incurred through June 30, 2012:

Now, therefore, in consideration of the mutual covenants contained herein, it is agreed as follows:

- 1. All outstanding charges of the City of San Luis for housing of fire personnel pursuant to Section 5 of the Intergovernmental Agreement for Fire Personnel Services dated the 22nd day of June, 2011 (hereinafter "IGA"), shall be modified and limited to the sum of \$48,138.00 for the total amount due the City of San Luis as of June 30, 2012 for such services.
- 2. All other terms and conditions of the IGA shall remain in full force and effect.
- 3. It is further understood the above modification is only for the period of the IGA through June 30, 2012. While the rate of Section 5 of the IGA remains unmodified for fiscal year 2012/2013, the parties agree that Somerton reserves the right to request similar modifications for and during fiscal year 2012/2013 should the need arise.

IN WITNESS WHEREOF, the parties have executed this Agreement this 22nd day of August, 2012.
