A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 26, 2014, IN THE CITY OF SAN LUIS, ARIZONA.

WHEREAS, the City of San Luis, Yuma County, Arizona did hold a Primary Election on the 26th day of August, 2014, for the election of one (1) Mayoral seat and three (3) Council Member seats;

WHEREAS, the 2014 Primary Election returns have been presented to and have been canvassed by the City Council;

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of San Luis, Yuma County, Arizona, as follows:

Section 1: That the total number of ballots cast at said primary election, as shown by the poll lists, was 2,177.

Section 2: That the total number of provisional ballots was as follows:

VC12-Cesar Chavez Cultural=47

VC13-San Luis City Hall=85

Total=132

Section 3: That the total number of provisional ballots to be verified was as follows:

VC12-Cesar Chavez Cultural=34

VC13-San Luis City Hall=79

Total=113

Section 4: That the total number of spoiled ballots was as follows:

VC12-Cesar Chavez Cultural=18

VC13-San Luis City Hall=9

Total=27




