A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 4, 2014, IN THE CITY OF SAN LUIS, ARIZONA.

WHEREAS, the City of San Luis, Yuma County, Arizona did hold a General Election on the 4th day of November, 2014, for the election of one (1) Council Member seat;

WHEREAS, the 2014 General Election returns have been presented to and have been canvassed by the City Council;

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of San Luis, Yuma County, Arizona, as follows:

Section 1: That the total number of ballots cast at said General Election, as shown by the poll lists, was 2,851.

Section 2: That the total number of provisional ballots was as follows:

VC12-Cesar Chavez Cultural=88

VC13-San Luis City Hall=114

Total=202

Section 3: That the total number of provisional ballots to be verified to count was as follows:

VC12-Cesar Chavez Cultural=70

VC13-San Luis City Hall=101

Total=171

Section 4: That the total number of spoiled ballots was as follows:

VC12-Cesar Chavez Cultural=0

VC13-San Luis City Hall=9

Total=9

Section 5: That the votes cast for the candidates for Council Member-four (4) year term were as follows:


