

AN ORDINANCE OF THE TOWN OF SAN LUIS, ARIZONA, AMENDING THE SAN LUIS CODE BY ADDING SECTION 2-6-8 TO ARTICLE 2-6 OF THE SAN LUIS CODE; SAID SECTION ANNEXING TERRITORY TO THE CORPORATE LIMITS OF THE TOWN OF SAN LUIS; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE TOWN COUNCIL OF SAN LUIS, ARIZONA AS FOLLOWS:

Section 1.

The San Luis code is hereby amended by adding Section 2-6-8 as follows:

Section 2-6-8 Annexation

The real property described herein is hereby annexed into the corporate limits of the Town of San Luis, Arizona, and, upon the effective date of this ordinance, shall become a part of the Town of San Luis, Arizona for all purposes whatsoever.


The property annexed is described as follows:

Beginning at the northwest corner of said NE 1/4 Section 12; thence S 0° 11' 23" E along the west line of said NE 1/4 Section 12 and the east boundary line of the PLAT OF SAN LUIS TOWNSITE ADDITION NO. 1 AND LOT NO. 9 a distance of 404.70 feet to the TRUE POINT OF BEGINNING: thence N 89° 28' 22" E parallel to the north line of said NE 1/4 Section 12 a distance of 2625.25 feet to a point on the east line of said NE 1/4 Section 12; thence S 0° 03' 38" E along said east line of the NE 1/4 Section 12 a distance of 1668.44 feet to a point on the easterly prolongation of the south right-of-way line of "B" Street as shown on said PLAT OF SAN LUIS TOWNSITE ADDITION NO. 1 AND LOT NO. 9; thence S 89° 49' 32" W along said easterly prolongation of the south right-of-way line of "B" Street a distance of 2621.44 feet to a point on the west line of said NE 1/4 Section 12; thence N 0° 11' 23" W a distance of 1652.27 feet to the TRUE POINT OF BEGINNING, containing 99.9915 Acres.

Section 2 - Declaration of an Emergency


