ORDINANCE # 176

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, AMENDING ORDINANCE #13, AS AMENDED, REZONING FOUR AND ONE HALF ACRES ON THE SOUTH SIDE OF COUNTY 21½ STREET 418 FEET WEST OF US HIGHWAY 95 FROM COUNTY RA-40 TO LIGHT INDUSTRIAL (LI) AND AMENDING THE ZONING MAP TO CONFORM THERETO.

Be it ordained by the Mayor and Council of the City of San Luis, Arizona as follows:

SECTION 1: That Ordinance #13, as amended, adopted by the Mayor and Council of the City of San Luis, Arizona on the 23rd day of October, 1980, be further amended in that the real property described as follows:

A parcel of land located in the north half of the southeast quarter of Section 35, Township 10 South, Range 25 West, of the Gila and Salt River Base and Meridian, being more particularly described as follows:

Commencing at the east quarter corner of said Section 35; thence south 89° 59' 35" west a distance of 418.00 feet to the **true point of beginning**; Thence south 00° 23' 59" east a distance of 395.00 feet to a point; thence south 89° 59' 35" west a distance of 510.00 feet to a point; thence north 00° 23' 59" west a distance of 395.00 feet to a point; thence north 89° 59' 35" east a distance of 510.00 feet to the **true point of beginning**. Containing 4.62 acres, more or less.

be rezoned from County RA-40 to Light Industrial (LI) as defined in Ordinance #13, as amended, that said property, upon this ordinance taking effect, shall be subject to all rules, regulations, and requirements of Ordinance #13, as amended pertaining to the Light Industrial (LI) Zoning District.


SECTION 2: That the zoning map adopted under said Ordinance No. 13, as amended, is hereby ordered to be changed and amended so as to show that said real property described in this ordinance is located within the district herein provided.

SECTION 3: That the above rezoning be subject to the following conditions:


1. The property owner dedicate to the City of San Luis the south forty feet of the north seventy-five feet of said property for road right-of-way.
2. That said right-of-way be improved as follows:
 1. Twelve inches of subgrade compacted to 95%;
 2. Eight inches of ABC compacted to 100%;
 3. Two inches of AC pavement compacted to 95%;
 4. A paved roadway width of twenty-six feet and
 5. A seal coat on the pavement.
