AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, AMENDING ORDINANCE NO. 13, AS AMENDED, REZONING A 7,579 SQ.FT. LOT FROM GENERAL COMMERCIAL (C-2) TO MEDIUM DENSITY RESIDENTIAL (R-1-6) FOR PROPERTY LOCATED AT 1211 N. LAKIN DRIVE, INTERNATIONAL PLAZA 2 SUBDIVISION, SAN LUIS, AZ AND AMENDING THE ZONING MAP TO CONFORM THERETO.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, AS FOLLOWS:


Section 1: That Ordinance #13, as amended, be further amended that the real property described as follows:

INTERNATIONAL PLAZA – PHASE 2, LOT 88

be rezoned from Community Commercial (C-2) to Medium Density Residential (R-1-6);

Section 2: That the zoning map adopted under said Ordinance #13, as amended, is hereby ordered to be changed so as to show that said real property described in this ordinance is located within the zoning district herein provided.

PASSED AND ADOPTED by the Mayor and City Council of the City of San Luis, Arizona, this 13th day of March, 2014.




