RESOLUTION NO. 1015

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA IN SUPPORT OF THE 2013 SAFER GRANT APPLICATION.

Whereas, the City of San Luis desires to provide the best level of fire suppression, emergency medical services and hazardous materials response to the community of San Luis, and,

Whereas, the City of San Luis has limited financial ability to provide for the level of staffing in the City of San Luis Fire Department to maximize the abilities of their personnel, and,

Whereas, there exists the ability to obtain financial assistance through a Staffing for Adequate Fire and Emergency Response (SAFER) Grant through the Federal Emergency Management Agency (FEMA), and,

Whereas, to be eligible for a SAFER Grant, the City Council of the City of San Luis must provide documentation of their awareness of the long-term obligations of a SAFER Grant; maintenance of existing staffing levels, incur no lay-offs during the period of performance of the grant and are committed to retain SAFER Grant personnel for one (1) year after the completion of the period of performance.

NOW THEREFORE BE IT RESOLVED, By the Mayor and Council of the City of San Luis, State of Arizona, as follows:

Section 1: That the City Council of the City of San Luis is fully aware of the requirements necessary to fulfill the criteria and obligations of a recipient of a SAFER Grant, and,

Section 2: That the City Council of the City of San Luis hereby approves and supports the 2013 SAFER Grant application, and,

Section 3: That the letter, attached hereto as Exhibit "A" and reincorporated as though fully set forth again in full, is hereby authorized and approved.


