The undersigned, under penalty of perjury, does hereby certify that all improvements made to the above project, at the address as stated above, by means of the building or improvement of structures or appurtenances of such property will be performed by a duly licensed contractor unless the entire structure is intended for the undersigned's sole occupancy.

This permit becomes null and void if the construction work is not begun within 180 days from date of issue or if at any time prior to final inspection and approval the works is suspended abandoned for a period of 180 days. It shall be the duty of the permit holder or agent to notify the Building Official that such work is ready for inspection, and provide access to and means for inspection of such work.

I understand owners who sell or rent property with improvements not completed by a licensed general contractor, may be subject to a Class 1 Misdemeanor under Arizona Revised Statutes §32-1151 and §32-1154. A Class 1 Misdemeanor is punishable by a fine not to exceed \$ 2,500 and/or one year in the County Jail. I understand and acknowledge the above certification. It shall be the duty of the permit holder or agent to notify the Building Official that such work is ready for inspection, and to provide access to and means for inspection of such work.
